You are currently in the SemtinZone industrial and chemical park, the largest industrial area in the Pardubice region, which covers an area of 7.5 km2. There are more than 135 companies and firms, which are also engaged in specialized chemical production. The largest company operating in the area is Synthesia, a.s., which also manages the SemtinZone industrial area. Due to the potential risk of chemical production, strict safety rules and restrictions are applied throughout the premises, which must be observed.

Entering the premises

Before entering, report to the reception or to the security guard. Also make sure that you do not violate any internal rules listed below.



Entry documents

Prior to entry, you will be given a Visitor's Card. Wear it on a visible position on your body, and return it to the security guard when you leave the site.



No Smoking

Smoking (incl. e-cigarettes) is prohibited inside SemtinZone and in your own vehicle as well. Areas for smoking are specially marked. Matches and lighters should be handed over upon entry.



No Alcohol

It is forbidden to enter the SemtinZone after consuming alcoholic beverages or narcotics. It is strictly prohibited to bring in and consume alcohol and narcotics.



No Photography

Photography and filming, as well as bringing cameras and video equipment, are prohibited in the whole area.



No weapons

It is forbidden to bring weapons in the whole area.



Mobile phones

Please **turn off your mobile phones** on certain workplaces.

Trafic rules in the area

Inside the area he Czech Road Traffic Regulation is applied. Intersections are not usually marked with signs, the priority of vehicles coming from the right applies. Pay attention to the reduced clearance height below the pipeline bridges. Parking of vehicles is allowed only in places designated for this purpose.



Maximum speed

The speed limit is 30 km/h. Be prepared, your speed may be randomly measured.



Customs declaration

The carrier of the goods is obliged to arrange for customs clearance and is obliged to report their arrival to the Customs Declaration of Synthesia, a.s. (Gate C)



Movement of Handling Equipment

Watch for forklift traffic in the area. Take extra care and be watchful near production buildings or warehouses.



Right of Way of Railway Vehicles

Before unprotected railway crossings, the driver is always obliged to stop and give way to railway traffic. CAUTION! Due to space constraints, there are no distance warning devices in front of railway crossings.

Safety guidelines

You are located in an area where are using dangerous chemicals, so carefully respect the rules and guidelines on the warning signs. Always follow the instructions of your guide, or employees of Synthesia, a.s.



Safety equipment

In all production buildings there is a general duty to wear protective clothing, shoes, helmet and glasses (or other prescribed protective equipment – e.g. mask, respirator, gloves).



Chemicals

Hazardous chemicals are used throughout the SemtinZone. Therefore, take extra care.



Warning of Danger

In the event of danger (fire, leakage of chemical substances, etc.) you will be warned by the fluctuating sound of sirens and the announcement on the radio. Keep calm and follow the instructions of the person accompanying you, or the instructions of the emergency services (dispatchers, plant fire brigade).
